## Minutes February 13, 2006

Present: L. Rothhaus, S. Barnes, Jody Vaillancourt, C. Morrison, F. Rothhaus

L. Rothhaus called the meeting to order at 7:40 PM.

#### **Petitioned Warrant Article**

Members discussed how to present the petitioned warrant article. J. Vaillancourt will take the lead in all presentations. L. Rothhaus, C. Morrison and S. Barnes will speak as well. Members noted that that the next presentation will be at the Budget Committee on February 16<sup>th</sup>.

Suggestions for comments to be made in the presentations included:

- The Committee is bringing forward an issue that needs discussion.
- Technology items have been bumped for the last three years
- The School Board had intended to put these items as a warrant article rather than part of the operating budget.
- The voters will get to decide.
- Windows 98 is not compatible with the Power School upgrade
- The new printers will save money on replacement ink cartridges.
- The TVs will finish the project to equip all classroom areas equal.
- The media distribution system in the library in combination with each classroom having its own TV results in getting more use out of the less equipment.

#### **Approval of Prior Minutes**

F. Rothhaus made a MOTION to approve the minutes of January  $9^{th}$ , subject to corrections. Second: L. Rothhaus. J. Vaillancourt requested that the minutes read, "The traffic situation at Mastricola Elementary School is in need of improvement at dismissal time." MOTION PASSED 5-0-0.
