

Minutes March 23, 2009

Present: G. Perry, R. Hendricks, F. Rothhaus, L. Rothhaus, S Heinrich (by speaker phone)

Excused: J. Vliet

R. Hendricks called the meeting to order at 7:38 PM. He said the meeting of March 9, 2009 was cancelled due to lack of a quorum.

R. Hendricks announced that S. Heinrich would be participating by speakerphone. He told the Committee that per RSA 91, once S. Heinrich was on the phone, roll-call votes were required for all votes taken. R Hendricks phoned S. Heinrich who told the Committee that he was on a bus in Boston, Massachusetts and that there were two other people on the bus with him.

Facilities Naming Requests

R. Hendricks announced that the sponsors and supporters of the two Facilities Naming Requests were present. He stated he would allow them to speak before the Committee voted on each request.

R. Hendricks explained to those present that the Committee had spent a lot of time developing the Facilities Naming Request naming application and the criteria by which it would approve such applications. He stated that the Committee had voted, to receive a recommendation, each application must receive a combined Committee average for each criteria in the matrix of 3 or better and a total of 17 or better. In addition, he said that the Committee's job was to make recommendations to the School Board, who would then have the final decision on each request.

Request to name "the Hot Top Area behind the Gym" at the James Mastricola Elementary School for Robert Kohler.

John Fabrizio, Principal of James Mastricola Elementary School (JMES) presented this request. He indicated the Parent Teacher group had raised funds that would be used to pay the costs of whatever type of memorial plaque was put up.

R. Hendricks stated that rules and regulations regarding what type of plaque were not something over which the Committee had authority.

Cheryl Jameson-White, a Special Education teacher at JMES and Marsha Kelly, a parent at JMES spoke in favor of this request.

R. Hendricks called for each member to announce their scores on the application rating matrix for this request.

Lee Richards, former MHS coach; Paul Drone, current MHS Physical Education teacher; State Representative James O'Neil, former Superintendent of School, State Representative Tony Pellegrino all spoke in support of this request. They also indicated that a letter of support had been provided by MHS Principal K. Johnson.

- R. Hendricks called for each member to announce their scores on the application rating matrix for this request.
