# Minutes July 26, 2004

W. Morrison called the meeting to order at 7:35 PM.

# **Report on Meeting with School Board**

- MES Parking W. Morrison reported that discussion on this issue had included a
  possibility that the School Board will ask for paving bids for just MES back parking lot
  and for MES plus the additional high school parking lots. E. Coburn stated this will be
  discussed again at the August 2<sup>nd</sup> School Board, but the projects will not be put forward
  until next year.
- 2. MUES Playground W. Morrison reported that the School Board had concerns about the closeness of the proposed playground to the street and to the parking lot. They had discussed the cost and height of chain link fence that would be needed. In addition, they had wondered about the area near the Smith Gym. This will also be discussed at the August 2<sup>nd</sup> meeting.
- C.I.P. W. Morrison reported that M. Shevenell had made the changes suggested by the Committee. E. Coburn reported that some School Board members felt that consolidation of the SAU offices could not wait until the MUES renovations were complete. E. Coburn also reported that a long-term study on demographics would be proposed to determine whether re-districting was necessary.

Morrison told her the Committee does not need School Board permission to do anything; but the Committee does "charges" at School Board request. J. Vaillancourt stated she wanted to know how much it would cost to return to two bus runs and she wanted to offer that information to the School Board.
