4. Current certified bargaining unit description:

Unit: All classroom personnel, librarians, guidance counselors, nurses, teaching specialists which include learning disabilities specialists, occupational therapists, speech therapists, reading specialists, education technology integrator, and technology coordinator.

Excluded: All other employees.

6. Modification request:

The bargaining unit shall include:

All full and part time professional staff whose position requires holding an appropriate credential issued by the NH Department of Education which shall also include school nurses, gifted & talented teachers, social emotional learning support specialists, and all positions designated as coordinator. Also included are the following full and part time professional staff whose position requires holding an appropriate license issued by the Office of Licensed Allied Health Professionals on behalf of the appropriate NH Office of Professional Licensure and Certification board: Speech-Language Pathologists and Occupational Therapists.

The bargaining unit shall exclude:

All persons employed by the state board of education, school psychologists, psychologists, title I tutors, paraeducators, dean of students, any administrator that is required to hold a credential issued by the NH Department of Education, and all other district employees.
