# Budget Overview 2020-21 Merrimack Middle School

The Merrimack Middle School budget proposal for 2020-21 shows continued commitment to the District Logic Model through attention to literacy, numeracy, technology, and school climate and safety.

This proposal includes increases in classroom supplies and office supplies to offset the rising cost of products. This proposal also includes the 3.5% increase in all accounts directly related to transportation, and a continuation of replacement of cafeteria tables that were purchased upon the opening of the school in 2004. Individual content area supply accounts are dependent on per pupil expenditures.
