#### Healthcare Cost Containment Committee Minutes September 14, 2016 3:30 p.m. to 5:00 p.m.

## 1. Welcome New Members

Marge Chiafery introduced new members Mary Ethier, Paraeducator at Thorntons Ferry Elementary School and Merrimack Educational Support Staff Association (MESSA) Representative, Rick Urda, Health and Physical Education Teacher at Merrimack High School and Kathleen Walczak, Special Education Teacher at Merrimack High School.

The School Board representative is unknown at this time.

Marge Chiafery shared an article that was published in the July 27, 2016 edition of the Union Leader that cited the state of New Hampshire for receiving an "A" for helping residents make educated choices on healthcare via a website, NHHealthCost.org.

# 2. Approval of June 1, 2016 Minutes

Mary Ethier moved (seconded by Shawn Croteau) to approve the June 1, 2016 minutes. Debie Clayton recommended all references to the Derry fitness fair be changed to the Derry wellness fair. The motion passed as amended 13-0-3 with Rick Urda, Mary Ethier and Kathleen Walczak abstaining.

# 3. Health Assessment Participation

### a) Rate for June, July, August

Bill Byron reported the Health Assessment participation rate for June, July and August was 54% each month. The eligibility count changed during the summer months due to new hires.

### b) Strategies for Fall Promotion

Linda Hastings reported new hire orientations include a thorough explanation of health insurance benefits by Debie Clayton and Bill Byron.

Representatives should contact new hires to encourage them to complete the Health Assessment. Linda Hastings will provide building representatives with a list of new hires eligible to complete the Health Assessment in September and in October.

Bill Byron reported he promotes the single sign on website, <u>www.healthtrustnh.org</u>, during all of his presentations.

Other opportunities to promote the HealthTrust single sign on include mentee meetings, faculty meetings, time in a computer lab for staff, training for staff on how an activity tracker can be synchronized to the HealthTrust's single sign on point accumulation.

# 4. June 2016 Staff Health Survey Results

Linda Hastings thanked Bill Byron for updating the HealthTrust terminology contained in the survey questions.

Linda Hastings reported 111 of the 130 people who completed the June Survey also completed the Health Assessment.

Bill Byron noted that some individuals do not want to complete the survey due to privacy concerns. HealthTrust does not share Health Assessment information but it cannot control the practice of third party vendors.

Sandy Swanson will send each representative an electronic copy of the June survey for posting.

# 5. Flex Spending

Debie Clayton reported the HealthTrust offers a flexible spending account administration service. The rate for the administration fee decreased recently. She presented this as another option for Merrimack School District.

Benefit Strategies is currently the district's vendor for this service.

## 6. Overview of Slice of Life Program for 2017

Bill Byron highlighted the 2017 Slice of Life Program. Details will be made public soon.

### Genetic Information Nondiscrimination Act (GINA)

In the spring of 2016, the U.S. Equal Employment Opportunity Commission (EEOC) released new wellness program regulations under the Genetic Information Nondiscrimination Act (GINA). These regulations prohibited an incentive for covered dependents age 18-26 for completing either a Health Assessment or a Biometric Health Screening. The EEOC has concluded that such information about dependent children constitutes family medical history and/or genetic information of the employee.

Effective January 1, 2017 dependent children including those age 18-26 will no longer be permitted to complete the Health Assessment and/or a Biometric Health Screening or receive financial incentives through the Slice of Life Points Program.

Instead, starting in 2017 dependent children age 18-26 will be eligible for the same reimbursements as dependent children under age 18 (up to \$200 per year reimbursement for eligible health and/or safety classes) through the Slice of Life Health Awareness Program.

Dependents can complete the Health Assessment through November 30.

Dependents can participate in the Biometric Health Screening through their doctor until November 1.

### Access

Effective January 1, 2017, enrollees, retirees and covered spouses who want to complete the Health Assessment and participate in Slice of Life will be required to have a secure online account at <u>www.healthtrustnh.org</u>.

### Rewards

Effective January 1, 2017 Slice of Life participants can earn up to \$475 in rewards.

- \$50 for completing a Health Assessment
- \$75 for completing a Biometric Health Screening
- \$50 (and up to 200 points) for engaging a Health Coach
- Points for connecting a mobile fitness device and/or using online trackers
- More opportunities to win quarterly VISA card drawings

Committee members were asked to share their plans to promote changes to the 2017 Slice of Life Program within their respective buildings during the October meeting.

The biometric screening for the Merrimack School District will occur on January 19, 2017 in the Merrimack High School cafeteria.
