Merrimack School Board Meeting Merrimack School District, SAU #26 Thursday, November 19, 2020 Remote Meeting

<u>Present:</u> Chair Guagliumi, Vice Chair Barnes, Board Members Schneider, Rothhaus, and Hardy. Also present were Superintendent McLaughlin, Assistant Superintendent for Business Shevenell, and Assistant Superintendent of Curriculum and Instruction Fabrizio.

1. Call to Order/Pledge of Allegiance

Chair Guagliumi called the meeting to order at 7:30 p.m.

Chair Guagliumi led the Pledge of Allegiance.

2. Public Comments

Chair Guagliumi stated public comments could be sent to publiccomment@sau26.org or by going to sau26.org where a meeting link was provided. She said all comments would be read and written into the record but noted the name and address of the speaker had to be provided.

3. COVID-19 Update: Administration's Recommendation Regarding the Status of Schools through Martin Luther King, Jr. Day

Superintendent McLaughlin stated on October 28th he provided an update to the School Board as well as to the community regarding the conditions from the beginning of school through October 28th. He said at that time they were in the "green" zone which meant it was safe to continue with the way things were going. He said he also provided information regarding a "red" scenario which meant there could be a sudden and unplanned closure. He noted they were in a "red" scenario when the Merrimack Middle School had to shut down in mid-October.

Superintendent McLaughlin said he also talked about the "purple" scenario which meant there could be a sudden or anticipated closure. He further said there was an increased amount of transmission on a national, state, and community level. He pointed out the daily PCR (Polymerase Chair Reaction) test positivity rate in New Hampshire alone was 4.3% and it was likely higher in the south-central region. He added according to the Department of Health and Human Services, a positivity rate of greater than 3% was indicative of community spread.

Superintendent McLaughlin stated the mask policy, the travel policy, and the communicable illness policy had all helped to enforce the conditions by which they could keep the schools open. He said they invested in PPE (personal protective equipment) and enforced social distancing protocols. He said he wanted to be clear that "in-school transmission" had been avoided.

Superintendent McLaughlin reiterated that what happened in a community happened in the schools. He said in a relatively short period of time the organizational supports that kept the schools going were becoming significantly strained.

Superintendent McLaughlin said from October 19th to October 30th there were 11 student absences at the Thorntons Ferry Elementary School as a result of COVID-19, he said the number included actual positive cases, close contact with an individual who tested positive or had to be quarantined. He then said the number of student absences from November 2nd to November 19th had climbed to 36. He also shared that the number of absences at the James Mastricola Elementary School went from 21 to 31; at Reeds Ferry the number went from 14 to 41; at Merrimack High School the number went from 74 to 103; the Merrimack Middle School was closed for the last two weeks of October but from November 2nd to November 19th the number was 35, and at James Mastricola Upper Elementary School the number went from 30 to 31.

Superintendent McLaughlin shared that there were 32 COVID related staff absences from October 19th to October 30th and that number had increased to 116 from November 2nd through November 19th.

Ms. Melissa Gagne, Human Resources Manager, stated there was a large decrease in substitute teachers with 76% of their active substitutes were not picking up any shifts. She said at the beginning of the current school year they had 18 floater substitutes and as of November 19th, they only had 14. She also said they had 5 floating substitute nurses Monday through Thursday as of the beginning of the current school year and to date, they were down to 3.

Ms. Gagne commented that typically most vacancies were filled but they currently had 17 paraprofessional vacancies, 8 food service/lunch monitor vacancies, 4 vacancies in the maintenance department, 2 vacancies in Title I, and 1 special education teacher vacancy.

Ms. Gagne stated staff had sought support through FFCRA (Families First Coronavirus Response Act) due to their home district's going remote for the holidays. She said recently Londonderry and Milford confirmed that they would go remote for a period of time, and Manchester and Nashua had been remote since the beginning of the school year.

Superintendent McLaughlin said the change in their circumstances over the past two weeks, not in terms of in-school transmission of COVID, but on the impacts of COVID and the ability to function safely and efficiently had been dramatically impacted. He said his recommendation to the School Board was to transition to remote instruction, pre-K through grade 12, beginning on November 30, 2020. Further, Superintendent McLaughlin said he anticipated a return to the hybrid model on January 19, 2021. He said holiday travel and gatherings would likely cause a spike in COVID cases.

Superintendent McLaughlin expressed his sincere gratitude to the students, staff, parents, and volunteers.

Vice Chair Barnes stated she felt the instruction could actually be compromised if the buildings were open. Superintendent McLaughlin replied he agreed because the number of services would be compromised due to a lack of staff.

Superintendent McLaughlin commented that there was a plan in progress to address the need for specialized instruction and he would keep the Board informed.

Board Member Schneider commented that he felt the way instruction was delivered remotely would have to be more aggressive.

Board Member Hardy commented she agreed that remote instruction needed to be more aggressive. She asked how a decision to go remote would affect sports. Superintendent McLaughlin replied things were developing very quickly and he was not yet prepared to answer that question but he was mindful of the importance of it.

Board Member Rothhaus commented it was her opinion that schools closing and going remote would only be a last case scenario. She also expressed concern regarding the students who required special education but said she felt it was important that all students be in school every day and was opposed to shutting the schools down for an eight-week period of time. She suggested closing the schools only until December 14th.

Chair Guagliumi asked what happened when a substitute was needed but not available. Superintendent McLaughlin replied in that case other people from the building who performed other duties had to cover those roles.

Assistant Superintendent of Curriculum and Instruction Fabrizio added they had cohorts and smaller classes for a reason, which was COVID. He said even the administrators were covering classrooms to keep the students safe.

Chair Guagliumi commented if the District went fully remote she would want the students to have additional instruction time and would like the administration to look at implementing other interventions. She also said she would like to see a comparison between the two cohorts.

Chair Guagliumi asked what the negative impact would be if the schools opened two weeks after Thanksgiving. Superintendent McLaughlin replied he was not sure what was going to happen but felt it was better to anticipate a problem rather than to hope things would go away even when all of the evidence was pointing in another direction.

Assistant Superintendent of Curriculum and Instruction Fabrizio commented time would not allow for combining cohorts and schedules would not be possible to be changed within the two weeks after Thanksgiving.

Board Member Schneider said given everything he had heard he would support remote instruction through to Martin Luther King, Jr. Day as long as they could guarantee they could come up with a more aggressive instructional schedule for all students.

Board Member Schneider moved (seconded by Vice Chair Barnes) for the District to go fully remote beginning November 30, 2020, through January 18, 2021, and that the District increases the instructional time where possible to students through increased instruction and support and utilize as much of the entire week as possible.

The motion passed 4 - 1 - 0. (Nay – Board Member Board Member Rothhaus)

Board Member Schneider commented that Ms. Heather Barker, Director of Student Services, needed to provide her thoughts and plans for how special education would be handled remotely at the next School Board meeting.

Chair Guagliumi asked how lunches would be distributed. Assistant Superintendent for Business Shevenell said they could still provide bagged lunches to be picked up at the high school or it could be delivered via STA (Student Transportation of America) excluding holidays.

4. Public Comments on Agenda Items

Vice Chair Barnes announced she had received approximately 27 public comments and while they would be added to the public record they would not be read into the record.

Vice Chair Barnes read aloud the following rules/procedures pertaining to public comments:

Speakers may offer such objective criticisms of school operations and programs as concern them. However, in public session, the Board will not hear personal complaints of school personnel nor will they hear complaints against any person connected with the school system. Other channels provide for the Board's consideration and disposition of legitimate complaints involving individuals.

The Board vests in its Chairman, or other presiding officer, the authority to terminate the remarks of any individual when they do not adhere to the rules established above as to content or time limitation.

At approximately 9:45 p.m. Vice Chair Barnes moved (seconded by Board Member Hardy) to adjourn.

The motion passed 5 - 0 - 0.

Unfortunately, not knowing what the recommendation actually is I apologize if this email is premature. Dr McLaughlin and multiple principals have time and time again assured us that even though we are still experiencing COVID 19 related cases in our schools there has not been an in school spread of the virus and all cases were contracted outside of the buildings.

Speaking for my household alone, I can tell you that my children thrive much better with in class instruction. I currently have a junior in multiple AP and honors courses as well as an eighth grader and moving to an all remote environment will not only affect their mental well being but even further isolate them from their peers. I completely understand moving to a remote environment if and when we see a large number of cases or in fact it starts to spread within the schools. I fully support and appreciate all the hard work the school board, school staff and Dr McLaughlin have had to do in this extra ordinary environment I just ask that you consider the mental and emotional wellbeing of our students and do not make judgements based on fear. Our family has made social sacrifices to limit our exposure in the community and we do not plan on traveling during the holidays. I am writing regarding the ongoing COVID situation and how that impacts the operation of our schools. As a parent of a student who receives special education services, as well as a special education service provider (in a neighboring district), I implore those involved in this decision making process to consider the impact of remote education on our special education students. Those are the students who have teams of up to 10 teachers or specialists and carefully crafted individualized plans in place in order for their educational needs to be met; those are the students who see regression in their skills after a summer break, or sometimes a holiday break, or even a weekend; those are the students who desperately need the routine, consistency, and security of an education in school, in person, and suffer the most from the closing of schools. I have witnessed this both personally and professionally. Despite the rising community numbers of COVID cases, the department of health has confirmed that transmission in schools remains low. IEP's are legally binding documents with no regard for a pandemic; these service hours need to be provided to keep our students moving forward, prevent regression, and to avoid putting further strain on parents and caregivers to become their child's teacher, aide, or therapist. While at some point it may be required or mandated by the Governor to close schools for safety reasons, this is not the case now. Please take this into consideration when you decide whether or not to close our district without such order, for any length of time.

Dear school board members,

Aa COVID cases rise along with refueled uncertainty I implore you to base your decisions regarding pivoting to full remote learning on data and not pressure.

Since March we have had more data to show that transmission of COVID is not happening in school setting. This is due to students and staff adhering to guidelines. We also now know that when both parties wear a mask risk of transmission between infection and uninfected is low. Furthermore, viral load and viral shedding in young children has been shown to be minimal and most of the time not enough to infect others.

An articlein Nature published 10/29 and reporting very low concerned for illness and transmission in children 14 yo and younger. Similar information seen in several other studies. That demographic (under 14 yo) is the demographic who should have limited screen time and more hands on / direct teacher interaction. Additionally the American Academy of Pediatrics does not support remote learning this is not what is best for our young children.

If we are truly an evidence based district, the evidence points to wearing masks, social distancing, temporary closure of dining in restaurants & gyms. In France, schools remained open with restaurants, gyms, and other indoor gatherings shut down and dramatic reduction in new cases.

We, as a community, should be learning from what is working worldwide and be basing our decision in data and fact.

Hi, this is Nicole Tomaselli, I live at 11 Knollwood Drive in Merrimack New Hampshire.

We have given this hybrid model "a go" for 10+ weeks, largely at the expense of working parents who are doing double duty or paying out of pocket for someone else to supervise their children. While I would prefer a "fully in" model of instruction where my kids attend school for 4 days, my questions are surrounding the expectations if this board votes to go fully remote.

Will you be combining A & B cohorts when remote? I would urge you to work towards achieving as many instructional hours as possible for all of our students. The students in Merrimack have missed so much direct teacher-led instruction already this year compared to learners in surrounding towns.

Can you please clarify what you mean by resumption of the schedule?

What does December 7-19 then the two weeks of January look like schedule wise?

A full daily schedule of zooms, direct small group instruction is needed every day.

(It IS possible to open a lesson for 10-15 minutes with the whole class (both A&B cohorts), break students into smaller groups with differentiated tasks and use the remainder of the class time to rotate between the groups to achieve small group instruction. This workshop model of teaching is a well known practice to educators and When done in combination with zoom, canvas or seesaw and exit tickets can be very effective for remote learning.)

There is no need to keep students into these half-sized cohorts if everyone is remote.

I am very disappointed that our school board voted tonight. Without having an articulate and well thought-out description of administrations' vision for remote instruction as well as clarifying the expectations for teachers and families - how could you have ever felt informed enough to vote?

Additionally I am at a loss as to why this district appears so illprepared for this inevitable pivot to fully remote instruction.

Giving working families another 2 days of NOTHING on November 30th and December 1st so that our district can prepare to teach remotely is unacceptable at this point in the school year. They should be ready to execute the plan and they should have described that plan for seamless transition this evening.
